

This list is organized by **type** of committee, then alphabetically by committee title. Below the lists of committee members is a description of each committee, organized the same way. You can click the name of the committee to jump down to the description.

There is a separate list that groups all committee by category. It is posted on the CFA website below this list.

Type of committee: There are three types” of committee, as follows:

FPSE: CFA sends a representative to meet with other FPSE locals (meetings usually in Vancouver). FPSE is the Federation of Post-Secondary Educators, a body that has locals in all the colleges and universities in BC except UBC, UVic, SFU, and UNBC. The CFA is “local 1.” Some of these committees are exclusively “FPSE committees,” and the CFA appoints one representative to that committee (e.g., Education Policy). Others are also CFA committees that work on issues here at CapU, with one representative from the committee attending meetings of the provincial committee, which FPSE organizes (e.g., Non-Regular Committee). And two of the committees are also joint CFA - CapU administration committees (Workplace Health & Safety; and Professional Development).

Joint: Committees that are joint between the university administration and the CFA. The committees’ members are faculty, administrators, and in some cases also MoveUp staff.

CFA: Committees that are internal to the union: the committees consist exclusively of CFA members.

Categories of committees: In 2017, the CFA executive identified the subject area of each committee, in an attempt to group committees that deal with similar issues, with two goals. First, to encourage members interested in particular issues to spot committees that interest them, or to sign up to be “on call” volunteers for issues within those categories, e.g., if there is a need for an ad hoc committee. Second, to help us to see opportunities to merge or modify our large number of existing committees, a project we will pursue during the 2017-18 year.

You can see the category names in the “category” column in this document. We will also post a separate list that sorts the committees by category, and lists the categories separately (the names of volunteers will be the same. In both lists, there is a set of “on-call” volunteers that is organized by category. That list appears first.
